Purpose, legal basis and time of data processing

Your personal data is processed by DEKRA Polska Sp. z o.o. and DEKRA Certification Sp. z o.o. based on various legal bases and for various purposes, including in particular:

- data obtained through forms - based on your consent, the aim of which is commensurate with the form and is to answer the questionnaire sent, or respond to the newsletter subscription, etc., for a period of 3 years from the date of the last contact in the matter being the subject of the question or until you withdraw the above-mentioned approval.
- data obtained for the performance of the contract – required as necessary, in order to provide the service and to inform about changes and of new/similar DEKRA services, *the direct marketing of own services, so-called, that may be of interest to you*, until co-operation ceases or your consent is removed and, *in the case of data processed for tax purposes, accounting, etc.*, until the time provided, under specific legal provisions, shall have expired
- data of job candidates - in accordance with the consent of the candidate for its processing under one or several, future recruitment processes.

Detailed information on the scope, purpose, basis and time of the processing of personal data is presented each time it is obtained, in such as the online form, General Terms and Conditions, etc.

Providing data is voluntary and does not result from any legal obligation. In the event of a refusal of access to the data, however, we will not be able to answer your questions, send offers, newsletters or implement other services which you may require from DEKRA.

Rights with regard to Data Processing

You have the right to access the data and rectify it, delete it or limit its processing, as well as the right to object to the processing; you also have the right to transfer data and withdraw your consent to the processing of personal data at any time by contacting our Data Protection Officer.

Any individual who decides that his/her data is being processed contrary to the law, may also lodge a complaint about it, to the President of the Office of Personal Data Protection.

Data safety

Our databases are properly secured against access by third parties and against exterior access.

The recipients of your data are authorised employees/associates of DEKRA Polska Sp. z o.o. and DEKRA Certification Sp. z o.o. who, in order to perform their duties, are permitted access thereto; these include employees of the sales department, marketing, etc.

Transferring Data to other entities

On the basis of a contract for entrusting data processing, your personal data may be transferred to entities who process personal data, such as IT systems and IT service providers, on behalf of DEKRA Certification Sp. z o.o. and DEKRA Polska Sp. z o.o.

Data transmission outside the EEA

Your data may be stored on servers located outside the EEA because we use ZOHO external CRM/ mailing systems. ZOHO is part of the US Privacy Shield programme, which confirms that the company meets European requirements in the area of secure data processing.

Automatic Data processing (profiling)

In the case of persons subscribing to DEKRA newsletters, we use 'ordinary profiling', *so-called*, that is, we follow the history of the opening of e-mails, so that, later, the subscriber can send useful information related to his/her interests.

Such profiling has no legal consequences, nor does it affect your situation in any significant way.

Automated decision-making takes place in the CRM system, this being the internal DEKRA database for managing contacts, gathering information and planning sales and marketing activities.

In other cases, your data will not be processed in an automated way including profiling.
